## FUNCTION HIRE TERMS & CONDITIONS

### Definitions

Venue Refers to Las Chicas of 201 – 203 Carlisle Street Balaclava Vic, 3183 ABN 42182693596

Hirer Refers to the person booking the function.

### Bookings

Bookings are not confirmed and secured until the security deposit is received by the venue from the hirer. If another party (or parties) is interested in a function date requested by the hirer, venue management will advise of the tentative interest and allow the hirer a 24 hour period to secure the booking with payment of the security deposit.

### Security Deposits

Exclusive Venue Use requires a 15% deposit to secure the booking for the hirer. All food must be paid for in full by the hirer no later than 48 hours prior to the event.

Security deposits must be paid by the hirer at least 30 days prior to the function date. Payment is accepted by Cash, Credit Card (Visa/MasterCard) or direct deposit.

The venue may utilise the security deposit to compensate the venue for any costs, losses, expenses or damages incurred or payable by the venue by reason of any breach of the hirer's obligations under these terms and conditions including any damage caused to the venue, but prior to doing so, must give written notice to the hirer of the breach and the amount claimed.

Otherwise, security deposits will be deducted from the hirer's final account at the end of the function, provided that the minimum spend is met by the hirer and subject to an acceptable inspection of premise and property by venue management. Payment of the balance of the function cost must be made in full at the conclusion of the function.

### Cancellation

In the event of booking cancellation by the hirer less than 30 days prior to function date, the hirer forfeits the security deposit bond. If the hirer cancels its booking within 48 hours then 50% of the total cost of the function will be charged to the hirer's credit card.

### Right of Refusal

When required the venue will employ a security company to monitor the function. If at any time during the function a patron in the space cannot be identified as a function guest, LAS CHICAS staff/security are to be notified and the patron will be instructed to leave the area.

### LAS CHICAS adheres to all Victorian laws and obligations

Management reserves the right to refuse service to or remove from the function premises and guest who displays unruly or intoxicated behaviour. Guests under the age of 18 must be under adult supervision and under no circumstances are to consume alcohol. Management retains the right to refuse entry or service of alcohol to any persons under 18 years of age or who cannot provide sufficient photographic proof of age.

### Damage

Repairs for damage to the premises and property caused by function guests will be the responsibility of the hirer including the cost of labour and materials and replacement equipment. The cost for such will be professionally assessed and deducted from the security deposit. In the event that damages exceed the security deposit the hirer is liable and will be charged accordingly.

## FUNCTION HIRE TERMS & CONDITIONS

### Audio Visual

Our internal sound system is available for all events so feel free to bring in an iPod or similar equipment. DJ's are to provide their own equipment including decks, cables, and speakers. Any alternate forms of audio should be discussed with management prior to event. Management reserves the right to control the volume of music at all times during the function. There is a microphone available for use so please arrange with management prior to function, if required.

### External Catering

No external food or drinks are permitted onto the premise unless authorised by management. We do allow cakes to be brought in but this may result in a cakeage being charged, please check with management.

### Belongings

The hirer and their guests are responsible for their belongings at all times during the event, should the hirer or guests wish to leave belongings for storage, arrangement for collection must be made with LAS CHICAS staff prior to commencement of function. LAS CHICAS accepts no responsibility for lost or damaged personal belongings.

### Representations

Under these terms and conditions, the hirer forever abandons and discharges any present or future claim, right or remedy against LAS CHICAS and releases LAS CHICAS from any present or future claim, right or remedy arising directly or indirectly in respect of or from:

- (a) any statement, representation, term, warranty, condition, promise or undertaking made, given or agreed to in the course of communication or in any negotiation, arrangement or understanding with respect to the subject matter or any term of these terms and conditions, whether:
  - (i) oral, written or implied; or
  - (ii) made, given or agreed to before the hirer agreeing to these terms and conditions;and
- (b) any conduct in relation to any prior negotiation, arrangement, understanding or agreement with respect to the subject matter or any term of these terms and conditions.

### Indemnity

- (a) Subject to para (b), the hirer hereby agrees to indemnify, to keep indemnified, and save harmless LAS CHICAS, its employees and agents, from and against all claims, demands, actions, damages, costs, losses and expenses of any nature whatsoever (Claims) which may be incurred directly or indirectly by reason of or in relation to the use of the venue, including without limitation, Claims arising out of or in connection with any breach by the hirer of these terms and conditions.
- (b) The hirer's obligations in para (a) do not apply to the extent that any Claim arises out of any act or omission of LAS CHICAS or any of its respective employees, agents or contractors.
- (c) LAS CHICAS shall not be liable to the hirer for any loss of life, personal injury or damage to or loss of property which may be suffered or sustained at the venue for any cause whatsoever, save where any such death, injury or damage results from a negligent act or omission of LAS CHICAS, its agents or employees.
- (d) The hirer agrees to use the venue at its own risk and releases LAS CHICAS from all claims and demands of any kind and from any liability which may arise in respect of any accident, damage or injury occurring to any person or property in or about the venue, unless caused by an act or omission of LAS CHICAS (except where acting on instructions of the hirer).
